## **Construction Sector Occupational Safety Card Refresher Course**

### **Introduction**

**Objectives:** This course aims to help workers in the construction industry who are Occupational Safety Card holders revise and update their knowledge on the basic safety and health training, enabling them to avoid occupational accidents or diseases which might occur in construction sites. Through the training, the participants will learn about the existing risks in construction sites, the pertinent legislation that must be complied with, as well as safety issues that workers should be aware of.

#### **Eligible candidates:**

1. Residents of the Macao S.A.R.;
2. Non-resident workers who are authorized to stay in the Macao S.A.R. and permitted to work in construction sites or venues where construction work takes place.

#### **Course content:**

1. Occupational safety and health legislation related to the construction sector ;
2. Basic safety concepts within the scope of construction works;
3. Prevention of occupational accidents and safe work methods;
4. Introduction, demonstration and practical training on the use of personal protective equipment.

**Study Materials:** Training material used in the “Construction Sector Occupational Safety Card” course.

**Duration:** 3 hours

**Class time:** 09:30-12:30

**Language of the course:** English / Portuguese / Cantonese / Mandarin

**Course certification:** Candidates who complete the training course, fulfil the practical training requirements and pass the exam will receive a training certificate from the Labour Affairs Bureau valid for 5 years .

**Course fee:** free of charge

**Course vacancies:** Each class will have a maximum number of 35 candidates (candidates will be accepted on a first come, first served basis).

**Venue:**

- Occupational Safety and Health Training Centre (Address: Rua de Francisco Xavier Pereira no. 137-145, Pou Fong Industrial Building, 2<sup>nd</sup> floor, Macao)

**How to enrol:**

1. Candidates may submit their application forms in person or through an authorised representatives at the following locations:
  - Head Office of the Labour Affairs Bureau (Address: Avenida do Dr. Francisco Vieira Machado 221-279, Edifício Advance Plaza, 2<sup>nd</sup> floor, Macao.)
  - Vocational Training Centre - Labour Affairs Bureau (Address: Istmo de Ferreira do Amaral, n° 101 – 105A, Tai Peng Industrial Building, Ground Floor, Phase 1, Macao.)
2. Candidates may apply on-line through the *Occupational Safety Card On-line Application System* (currently only available to holders of the Macao Resident Identity Card).

**Required documents:**

1. Completed application form;
2. One (1) colour bareheaded frontal photo with a size of 1.5 x 1.0 inches (passport-sized photo);
3. One (1) photocopy of the applicable valid identification documents described below
  - **Macau residents**
    1. Macau S.A.R. Resident ID Card (B.I.R.) (front and back)
  - **Non-resident workers**
    1. Non-resident Worker Identification Card (commonly known as the *Blue Card*) or
    2. Passport / Hong Kong I.D. card, along with the *Non-Resident Worker's Authorization to Stay / Temporary Authorization to Stay*.
